Commander Jan Cloud opened the meeting without ceremony.

Roll call was held and the results are indicated above and a quorum was **not** established. Therefore, no business could be conducted.

The meeting was shortened since there was not a quorum and only Membership and SAL reports were given.

Although a Finance Report was not presented, Gary Smith stated that a review of finance books for 2014, 2015, 2016 & 2017 was completed and there were no issues found. Also, bonding for officers that do or may handle money was renewed for 3 years.

Membership Report: The membership report was presented by Gary Smith. Post 111 has exceeded its membership goal and stands at 107.87%, which is 137 members. Post 111 is in 4th place among 20 Posts for meeting and exceeding goal.

2. Gary Smith and David Schneider are still working on the virtual meeting capability.
3. Name badges for Post 111 officers. After tonight's election of officers, Gary Smith will order name badges for each officer. These badges are to be worn when officers attend events in a public or official capacity. The item was approved at a previous meeting.
4. Form 401: Statement of Change of name of agent. Gary Smith is currently the agent of record for the State of Texas regarding Post 111's non-profit status, due again in 2021. Also, form 802, another 501c status form, must be filled out every 4 years. Bob Betik is the new agent.
5. Now that Post 111 elections are completed, an internal review of the books is required. The review meeting for this purpose has been set for Tues., 08 May at 09:00 at the Post 111 office. This review will require a minimum of 3 people and should take about 2 hours. Any currently paid up members are welcome to participate.
